

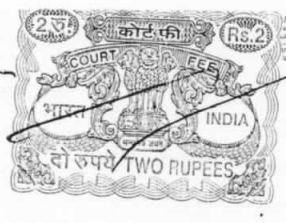
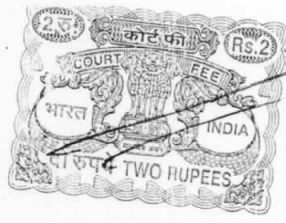

CAVEAT PETITION UNDER SECTION 148A READ WITH
SECTION 151 CPC, 1908.

RESPECTFULLY SHOWETH

1. That the Delhi Public School CGHS Ltd., (hereinafter called the Caveator society) is a cooperative group housing society registered under the Delhi Cooperative Societies Act, 2003 and Delhi Cooperative Societies Rules, 2007 read with approved Bye-Laws of the society.
2. That the respondents no. 1 to 4 were enrolled as members of the society and is in possession of their respective flats.
3. That the respondents no. 1 to 4 are habitual to create unnecessary hue-n-cry on every work initiated by the duly elected managing committee of the society.
4. That very recently, the said respondents no. 1 to 4 has approached the Registrar of Cooperative Societies (appellate authority) and were successful to grab an order dated 01.02.2018, which itself is non-speaking and passed in a mechanical and hasty manner. The caveator society has already filed a review petition against the said order before the appropriate forum.
5. That it is apprehended that the respondents no. 1 to 4 are only harassing the Caveator society for their vested

interest and may approach this Hon'ble Court on the basis of their flimsy and baseless contentions.

6. That the Caveator has a right to be heard before any order is passed by this Hon'ble Court, in case the defendants herein approach this Hon'ble Court by way of any suit, appeal, application for stay or otherwise.

PRAYER

It is therefore, most humbly and respectfully prayed that notice may be served to the Caveator society before passing any interim order on the suit, appeal, application for stay of the respondents herein.

Any other order deemed fit and proper may be passed accordingly.
